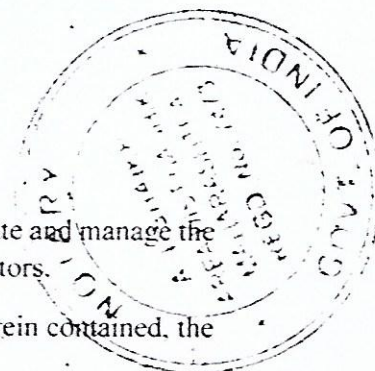
CANTEEN MANAGEMENT AGREEMENT

This Agreement is made and entered into on this 16/06/2025, by and between: Jawahar Education Society's, Institute of Technology, Management and Research, Nashik, represented by its Principal, Dr. M.V. Bhatkar, having its office at Gowardhan, Gangapur Road, Nashik, hereinafter referred to as the "COLLEGE",

AND

M/s DAKSHINAYAN, represented by Mr. VINAYAK D. KAPASE (CANTEEN MANAGER), having its office/residence at Flat No. 2, Gopal Niwas, Behind Someshwar Lawns, Suvarnkar Nagar, Nashik West, Nashik- 422 013 hereinafter referred to as the "CANTEEN MANAGER".

WHEREAS, the COLLEGE desires to appoint the CANTEEN MANAGER to operate and manage the canteen facility within the college premises for the benefit of students, staff, and visitors.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the parties agree as follows:

1. Duration of Agreement

This agreement shall be valid for **one year**, commencing from **16/06/2025** and ending on **31/05/2026**, unless terminated earlier as per the terms of this Agreement.

2. Canteen Premises

The COLLEGE shall provide the canteen premises located **within the College** for the operation of the canteen.

3. Rent and Deposit

- The CANTEEN MANAGER shall pay a monthly rent of ₹ **10,000/-** to the COLLEGE, payable on or before the **10th of every month**.
- A refundable security deposit of ₹ **50,000/-** shall be paid by the CANTEEN MANAGER at the time of signing this agreement. The deposit shall be refunded at the end of the contract period after adjusting for any dues or damages.

4. Menu and Rates

- The menu and prices of items shall be **pre-approved by the COLLEGE**.
- The CANTEEN MANAGER shall not make any changes in the prices or menu without written approval from the COLLEGE authorities.
- The rates shall be reasonable and affordable for students and staff.

5. Hygiene and Cleanliness

- The CANTEEN MANAGER shall **maintain high standards of hygiene and cleanliness** in and around the canteen area.
- All food items must be prepared in hygienic manner using fresh and good-quality ingredients.
- The CANTEEN MANAGER shall ensure the canteen staff are well-groomed and wear clean uniforms.

6. Waste Management

- Proper disposal of waste is the responsibility of the CANTEEN MANAGER.
- Garbage bins must be provided, and waste must be disposed of as per local municipal regulations.

7. Furniture and Equipment

- Any furniture, utensils, or equipment provided by the COLLEGE shall remain its property.

Contd...3

- The CANTEEN MANAGER shall be responsible for the maintenance of such items and shall return them in good condition, subject to normal wear and tear.

8. Breakage and Damages

- Any breakage or damage to college property due to negligence or mishandling by the CANTEEN MANAGER or its staff shall be repaired or compensated by the CANTEEN MANAGER.

9. Staff and Labor Laws

- The CANTEEN MANAGER shall employ adequate staff for smooth operations.
- The staff shall be the employees of the CANTEEN MANAGER, and the COLLEGE shall have no liability in this regard.
- The CANTEEN MANAGER shall comply with all applicable labor laws, including payment of minimum wages, insurance, and statutory benefits.

10. Inspection

- The COLLEGE reserves the right to inspect the canteen premises and food quality at any time without prior notice.

11. Termination

This Agreement may be terminated by either party by giving one month's written notice. The COLLEGE reserves the right to terminate the agreement without notice for breach of terms, substandard services, or complaints from stakeholders.

12. Indemnity

The CANTEEN MANAGER shall indemnify and hold harmless the COLLEGE against any claims, damages, or liabilities arising from the operation of the canteen.

13. Jurisdiction

This Agreement shall be governed by the laws of the government. Any disputes shall be subject to the jurisdiction of the courts located at Nashik.

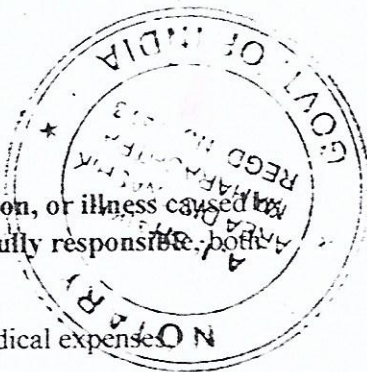
14. Access Restrictions

- The CANTEEN shall serve only students, staff, and authorized visitors of the COLLEGE during official college hours.
- The CANTEEN shall not be opened or operated for outsiders or the general public after college hours under any circumstances.
- Any violation of this condition will be considered a breach of the agreement and may result in immediate termination.

15. Food Safety and Liability

- The CANTEEN MANAGER shall be solely responsible for ensuring that all food and beverages served are safe for consumption.

- In the event of any incident related to food poisoning, contamination, or illness caused by food served at the canteen, the CANTEEN MANAGER shall be fully responsible, both legally and financially.
- The CANTEEN MANAGER shall bear all liabilities, including medical expenses, compensation, and any legal actions arising due to such incidents.
- The COLLEGE shall not be held liable for any such occurrences.

16. Staff Insurance

- The CANTEEN MANAGER shall ensure that all staff employed in the canteen are covered under appropriate accident insurance and health insurance policies.
- Proof of such insurance coverage shall be submitted to the COLLEGE at the time of commencement of services and updated as necessary.
- The COLLEGE shall not be liable for any injury, accident, or health-related issue concerning the canteen staff during their employment.

17. Prohibition of Residential Use

- The CANTEEN premises shall not be used for any residential or accommodation purposes by the CANTEEN MANAGER, its staff, or any other individual.
- No one shall be allowed to stay overnight or reside in the canteen area under any circumstances.
- Violation of this condition shall be treated as a serious breach of contract and may lead to immediate termination of the agreement.

18. Complaint Register

- The CANTEEN MANAGER shall maintain a **complaint and suggestion register** at the canteen premises at all times.
- The **register shall be visible** and easily accessible to students, staff, and visitors.
- Any complaints or suggestions recorded shall be reviewed and acted upon promptly.
- The COLLEGE reserves the right to inspect the complaint register periodically and assess the response to issues raised.


19. No Subletting

- The CANTEEN MANAGER shall **not assign, transfer, or sublet the canteen contract** or any part of the premises to any third party.
- The management and operation of the canteen shall be carried out exclusively by the CANTEEN MANAGER as per the terms of this agreement.
- Any attempt to sublet or delegate the responsibilities under this agreement shall be considered a serious breach and may lead to immediate termination of the contract.
